Responding to stalker's actions may reinforce their behavior. Whether or not you choose to petition for a Stalking Protection Order, documenting the stalking behavior is strongly recommended. Relying on trusted friends and family is important for victims of stalking to help keep victims safer and also reduce the isolation and feelings of desperation that stalking victims may experience.

When out of the house or work environment, try not to travel alone and try to stay in public areas. However, for some people, such as undocumented immigrants living in a county where the police may report them to Immigration, this may not be a safe alternative. One stalking victim's ex-boyfriend learned of her new address by "innocently" inquiring Safety for Stalking Victims the local oil change station if she had recently brought in their car for an oil change.

The creation of a safety plan can assist victims in doing. Legal sanctions may not openly post information such as: Your full name, home or cell telephone numbers, home address, name of school, date of birth, social security number, credit card numbers or Safety for Stalking Victims of yourself, your school or your hometown. It directs the stalker to stay away from you and not to attempt to contact you in any way.
